### JASON LACEY SLATED FOR FELLOWSHIP IN AMERICAN COLLEGE OF EMPLOYEE BENEFITS COUNSEL

WICHITA, KAN. – Jason Lacey, managing partner of law firm Foulston Siefkin LLP, was elected by the Board of Governors of the American College of Employee Benefits Counsel (ACEBC) to be inducted as a Fellow in the College at the College's Annual Dinner to be held at the Chicago Club in Chicago, Ill., on Sept. 17, 2022.
