

## BUSINESS LEGAL UPDATE - TERMINATION OF THE KANSAS AD ASTRA REOPEN PLAN

Foulston has produced a series of issue alerts as we continue to monitor the evolving COVID-19 situation and provide additional guidance. Please find all updates and our latest resources available <u>here</u>.

On May 26, the Kansas governor *ended the state-wide phased reopening plan of business, facility, venue and event operating restrictions, and mass gathering limits.* The governor's executive order imposing the mandatory Ad Astra Reopen Plan was replaced today by the governor switching the plan and its additional covid.ks.gov online resources to be guidance that remains available for local or business use.

Any similar pandemic response restrictions now will be decided by each Kansas local health official or government. Some local jurisdictions may choose to avoid any pandemic-response requirements, some could select their own ideas (including restrictions affecting essential businesses), and others might continue with the governor's Ad Astra Reopen Plan.

Businesses operating in Kansas remain benefited by the continuance of multiple executive orders responding to pandemic effects (examples: remote notarial acts, alcoholic beverage sales, deferred tax deadlines, telemed, various licensure and registration relief). Also, Kansas travel quarantines for non-essential business travel, other governmental (local, state, federal) law applicable to a specific business, and the common law duty of care – all remain in effect.

A new Kansas disaster emergency proclamation is in effect, and the governor called for a special legislative session commencing June 3. The Kansas 2020 legislative session wrapped up last week (review here Foulston's Kansas legislative session wrap-up discussion).
