### FOULSTON SIEFKIN LLP ELECTS JASON LACEY MANAGING PARTNER, CONFIRMS EXECUTIVE COMMITTEE SLATE

Four additional executive committee members, also elected by firm partners, work closely with Lacey to govern the firm on the partners' behalf. Those executive committee members elected for 2021 are Kevin Arnel, Brooke Bennett Aziere, Tony Rupp, and Bill Wood. This represents no change in the composition of the executive committee, with only the managing partner role changing.
